## The Role

---

As a Services Auditor at NSI, you will deliver robust, high quality third party audits to applicant and approved companies, against a range of quality management and scheme specific technical standards.

Home based with a high degree of autonomy, you will maintain a portfolio of clients and manage your own diary to ensure clients' audits happen on time.

Day to day, the auditor's role is varied. For example, one day you may be observing security officers and interviewing staff, and the next you may be interviewing the CEO of a business, whilst auditing the business's quality management system. Whilst all approved companies work to the same standards, there is great diversity in the nature of the organisations and the way that they operate. In your role as an auditor, you will help organisations meet the standards they aspire to by raising findings where there is an opportunity for the business to improve, or where there is a significant failing.

The role will involve auditing up to 15 days a month with the remainder of the days being utilised for report writing, travel, audit planning and reviewing client responses.

Some schemes will require you to audit in the evening, or at a weekend (at such time as the service being assessed is available to assess). Time off in lieu is provided for work out of normal working hours.

Through delivery of a highly professional audit service, you will build relationships with your clients and help NSI in its mission to raise standards in industry.

## Experience
