Annex 2

Regulation A.2

There are various types of NSI approval according to:

- the particular activity/ies within the fire, security and related facilities management sectors in which the company applying for NSI approval (or holding NSI approval) provides services and for which the company has been assessed known as the 'scope of company activity'; and
- the level of approval the company has achieved (Gold or Silver).

The types of NSI approval are as follows:
