



## Security Systems: British Standards and NSI Codes of Practice

Approval by NSI requires audits against industry recognised British Standards and/or Codes of Practice. Before audits for approval can take place, companies should ensure they have access to and are working in accordance to the appropriate standard(s) – see list below.

**Note:** This document does not list all the standards and codes of practice that must be complied with in order to meet the rules of the NACOSS Gold and Systems Silver approval schemes (for example see PD 6662).
